I. Director's Report

- Executive Director Judith Velasco commenced the meeting by reviewing the Director's Report as quorum had not yet been achieved.

A. Workforce Innovation and Opportunity Act (WIOA) Updates

1. Ms. Velasco shared that a discussion will be held during the full board meeting. The discussion will be centered on the human capital needs in BioScience. The discussion will be led by VWDB staff member, MaryAnn Pranke.
2. Ms. Velasco announced that the VWDB is moving forward with the contractual process with Copy & Design.
 - a. The goal is for Copy & Design to develop a new website for the VWDB and the Verdugo Jobs Center (VJC), as well as create a board member tool kit. The tool kit will be utilized to articulate the mission and goals of the VWDB.
 - i. Ms. Velasco disseminated samples of the work Copy & Design has completed for the Los Angeles Basin Regional Planning Unit.
3. Ms. Velasco announced that the State had issued a draft directive for high performing boards. The State is currently soliciting comments on this directive. The VWDB will move forward in submitting an application if the directive is approved.
4. Gavin Koon suggested that the VWDB have a keynote at the quarterly meetings, which may help improve attendance.
